












































































































































































































ACCOUNTABILITY: AN ENVIRONMENT OF OVERSIGHT THAT ENSURES COMPLIANCE WITH LAWS, PROCEDURES AND REGULA-TIONS. WHILE PROMOTING TRANSPARENCY, ACCESS TO INFORMATION AND PUBLIC INTEGRITY.

HUMAN RIGHTS: RIGHTS INHERENT TO ALL HUMAN BEINGS, WITHOUT DISTINCTION AS TO RACE, COLOUR, GENDER, LANGUAGE, RELIGION, POLITICAL OR OTHER OPINION, NATIONAL OR SOCIAL ORIGIN, PROPERTY, BIRTH OR OTHER STATUS. ALL HUMAN RIGHTS, WHETHER THEY ARE CIVIL AND POLITICAL RIGHTS, SUCH AS THE RIGHT TO LIFE, EQUALITY BEFORE THE LAW AND FREEDOM OF EXPRESSION; ECONOMIC, SOCIAL AND CULTURAL RIGHTS, SUCH AS THE RIGHTS TO WORK, SOCIAL SECURITY AND EDUCATION, OR COLLECTIVE RIGHTS, SUCH AS THE RIGHTS TO DEVELOPMENT AND SELF-DETERMINATION ARE INDIVISIBLE. INTERRELATED AND INTERDEPENDENT.

JUSTICE: AN IDEAL OF ACCOUNTABILITY AND FAIRNESS IN THE PROTECTION AND VINDICATION OF RIGHTS AND THE PREVENTION AND PUNISHMENT OF WRONGS. JUSTICE IMPLIES REGARD FOR THE RIGHTS OF THE ACCUSED, FOR THE INTERESTS OF VICTIMS AND FOR THE WELL-BEING OF SOCIETY AT LARGE.

ORGANIZED CRIMINAL GROUP: STRUCTURED GROUP OF THREE OR MORE PERSONS, EXISTING FOR A PERIOD OF TIME AND ACTING IN CONCERT WITH THE AIM OF COMMITTING ONE OR MORE SERIOUS CRIMES OR OFFENCES, IN ORDER TO OBTAIN, DIRECTLY OR INDIRECTLY, A FINANCIAL OR OTHER MATERIAL BENEFIT.

RULE OF LAW: A PRINCIPLE OF GOVERNANCE IN WHICH ALL PERSONS, INSTITUTIONS AND ENTITIES, PUBLIC AND PRIVATE, INCLUDING THE STATE ITSELF, ARE ACCOUNTABLE TO LAWS THAT ARE PUBLICLY PROMULGATED, EQUALLY ENFORCED AND INDEPENDENTLY ADJUDICATED AND WHICH ARE CONSISTENT WITH INTERNATIONAL HUMAN RIGHTS NORMS AND STANDARDS.

VIOLENT EXTREMISM: THE BELIEFS AND ACTIONS OF PEOPLE WHO SUPPORT OR USE VIOLENCE TO ACHIEVE IDEOLOGICAL, RELIGIOUS OR POLITICAL GOALS. IN OTHER WORDS, THE WILLINGNESS OF AN INDIVIDUAL TO USE VIOLENCE OR THE THREAT OF IT TO ENFORCE CERTAIN RADICAL OR EXTREMIST VIEWS.





16.3: Promote the rule of law at the national and international levels and ensure equal access to justice for all.

16.A: Strengthen relevant national institutions, including through international cooperation, for building capacity at all levels, in particular in developing countries, to prevent violence and combat terrorism and crime.
